NOTIFICATION

WHEREAS Section 182 of the Elections Act 2017 imposes ban on convening, holding or attending any public meeting, or promoting or joining in any procession, within the area of a constituency during a period of forty-eight hours ending at midnight following the conclusion of the poll day.

AND WHEREAS, the Elections to constituency GBA-3, Gilgit-III of Gilgit-Baltistan Assembly is scheduled to be held on 22nd November, 2020.

NOW THEREFORE, in exercise of powers conferred upon him under section 182 of the Elections Act, 2017 (Act No. XXXIII), the Honorable Chief Election Commissioner Gilgit-Baltistan has been pleased to direct that no person shall convene, hold or attend any public meeting, or promote or join in any procession from midnight 12:00 AM, 20th November 2020 for a period of forty-eight hours within constituency GBA-3, Gilgit-III of Gilgit-Baltistan Assembly.
